COVID-19 UPDATE & MCERTS CERTIFICATON

During these uncertain and unpredictable times, CSA Group continue to protect the well-being of our employees, customers and communities they work and live in whilst also trying to get certain parts of our business back up and running in what will be the new normal way of doing things.

CSA Group will continue to implement the following:-

- All office based personnel (non-lab staff) will work from home

- MCERTS written examinations will be carried out external locations throughout the UK and will be adjudicated by CSA Associates
- Level 2 Interviews will be carried out virtually in collaboration with our customers.
- Stage 3 of the Certification Extension process has been implemented for those candidates in Dublin, who were unable to undertake their exams during October & November due to Southern Irelands lockdown and restrictions, certificates are being extended to August 2021

Changes to TE3 Examination Syllabus

Please note that the MCERTS Syllabus is undergoing some updates to include the addition of the following standards, which will be included as part of the Examination from 1st March 2022

CEN TS 17340:2020 Stationary source emissions – Determination of mass concentration of fluorinated compounds expressed as HF – standard reference method.

EN ISO 21877:2019 Stationary source emissions – Determination of the mass concentration of ammonia – manual method
